Terms and Conditions

1 Condition of the Vehicle

- (a) The Hirer acknowledges that the Vehicle is the property of Bushtucker Tours and that at the commencement of the Rental Period the Vehicle was in a good and clean condition containing, so far as is detectable on an inspection of the Vehicle, only those defects detailed in any condition report signed by the Hirer.
- (b) The vehicle hired will leave the depot with a full tank of fuel.
- (c) The Hirer agrees to keep the Vehicle locked and the keys under his her or their control at all times.
- (d) The Hirer agrees to properly maintain engine oils and coolant levels to manufacturer's specifications for the Vehicle at all times during the Rental Period and immediately report any damage or loss to the Vehicle to Bushtucker Tours.

2 Use of Vehicle

- (a) The Hirer will hold a current Drivers Licence.
- (b) For the hire of 21 seater coaster, the Hirer will hold a current LR licence.
- (c) The Hirer agrees that only the persons listed, are to drive the vehicle.
- (d) The Hirer agrees that they will not exceed the licensed amount of passengers in the vehicle. Hiaces seat maximum of 12 people and Coasters 21 people
- (e) The Hirer agrees that there will be no alcohol consumed on the vehicle.
- (f) The Hirer agrees that Bushtucker Tours are not responsible for any damage that may occur at locations visited while vehicle is on hire.

3 Return of Vehicle

- (a) The Hirer agrees that the vehicle will be returned to the place of pick up, on the date and by the time arranged with Bushtucker Tours. If not, charges will apply.
- (b) The Hirer agrees that all buses are to be returned in the same condition as it was at the commencement of the Rental period (fair wear and tear accepted). If not clean, a cleaning fee will be deducted from the bond.
- (c) The Hirer agrees that the vehicle will be returned with a full tank of fuel.

4 Payment

- (a) The Hirer agrees that he or she will pay for all damages occurred while the vehicle was hired to them.
- (b) The Hirer agrees that if any damage does occur (which is covered with insurance), while on hire they will pay an excess of \$350.
- (c) The Hirer agrees that all rental charges, including the bond of \$500 cash, will be paid prior to the vehicle leaving Bushtucker Tours depot.
- (d) The Hirer irrevocably and unconditionally authorizes Bushtucker Tours to charge all outstanding monies owed to Bushtucker Tours to their Credit Card.
